Additionally, he is involved in publishing book chapters, conference proceedings, and high-impact journal articles, demonstrating his extensive academic experience.



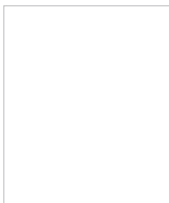
